FUEL SURCHARGE TARIFF

A fuel surcharge will be assessed as outlined below:

1. On all local carload traffic originating and terminating on the RRVW and billed by the RRVW when freight rate tariffs make reference to this surcharge.
2. The fuel surcharge will be billed against the payer of freight charges.

RRVW will apply a fuel surcharge to linehaul freight charges based on the monthly average price of U.S. No. 2 Diesel Midwest Area Retail Sales by All Types (dollars per gallon) On-Highway Diesel (OHD).

The source for the price of the OHD is the U.S. Department of Energy's EIA Midwest Retail On-Highway Diesel Prices Report , whose monthly average price is available at https://www.eia.gov/dnav/pet/pet_pri_gnd_dcus_r20_m.htm

When the monthly average price of OHD equals or exceeds \$2.75 in the second calendar month prior to the month in which the fuel surcharge is applied, the fuel surcharge rate per mile as shown in the OHD Fuel Surcharge Table will be applied to the linehaul freight charge. For example, the surcharge amount in April will be calculated from the monthly average OHD price during February. Rail mileage is calculated using 3rd party software Railconnect RC2 (Wabtec Corporation) on each linehaul movement. Where the rail miles are not available through Railconnect RC2, RRVW will calculate and publish the mileage independently.

The Date of surcharge shall be applies as follows:
